To search Act from Act list, please enter minimum 3 characters of the Act description and click on search button

All the Acts matching the search criteria are displayed in the Act Type select box. Select the required Act Type from the select box.

If no search criteria are specified then, all the Acts are displayed, select the required Act Type from the select box.

In the Under Section box, enter the Section which you want to search under the selected Act. If the section is not entered in the Under Section box, then the Cases belonging to all the sections under the selected Act will be listed.

Click on either the Pending or Disposed option button, according to the status of the Case.

Enter the Captcha (the 5 alphanumeric characters shown on the screen) in the text box provided.

Click on the Go button, to get the Cases satisfying the given Act and Under Section condition.

Click on the adjacent View button from the list, to see the Case History of the respective Case.
