Agenda: Election of Office Bearers of PWCAOA for 2021-2022
Discussion started with questioning of not received of official communication e-mail for calling Meeting. Mr. Naburan has taken lead and sent message to all members on whatsapp around 08:30 PM on 29-05-2021 but no one has responded. Then discussion started with Schedule of Meeting for selection of Office Bearer for PWCAOA.

Mr. Nitin M, Keshav Murthy, VjayKumar requested all Board of Managers to give at least 3 to 7 days of time for those who couldn't make to Meeting for Office Bearer selection process.

Mr. Vijaykumar mentioned, he got 7 approval letters in e-mail for support and choice of Office Bearer from the Board of Managers who couldn't join the Meeting.

Mr. Satish K mentioned method of voting should be physical and not any other mode of communication. Election should be conducted today if majority agree with the people available physically to vote.

Mr. Nitin M said, Board members should be given choice of voting either with Physical presence or via Phone or e-mail or post.

All available members agreed that people do not present in the meeting cannot be considered for Office Bearer.
Few Board Members raised point for conducting election as per bye-laws i.e. election to be conducted in General Board of Meeting. Due to Pandemic GBM cannot be conducted so with precedent set in past, this Election method is valid.
Nitin M said elected OB should be ratified in General Board of Meeting.

1. Mr. Subramanian asked to vote for option to conduct election today or after week or post lockdown.
As option of Election of OB Today Mr. VijayKumar, Mr. Keshav Murthy, Mr. Gowrishankar, Mr. Nitin M, Mr. Abdul S, Mr. Pritam Marik, Mr. Pradeep Kumar, Mr. Samidh Chatterjee, Mr. Anand lyer, Mr. Harirajan supported and requested to complete this process today itself.
So as per majority of 10 members out total present BoM agreed to conduct election today, EC decided to conduct election of OB today 30-05-2021.
2. Mr. Satish reiterated election can be conducted today but with available members in meeting only. After week also fine but physical presence is must. This option backed by Mr. Satish, Mr. Chakrapani, Mr. Pradeep Kumar, Mr. Naburan C, Mr. Yusuf, Mr. Anoop Kumar, Mr. Samidh, Mr. Pritam were in favor.
3. Election of OB to be conducted with Secret Ballot method.
4. Board of Managers who are out of station will vote via phone call. EC will call all 4 members and take vote of all members.
5. EC explained rules of Election of all Office Bearer posts through Secret Ballot.

Mr. VijayKumar has been voted by 10 members.
