With reference to the above, 'No Objection Certificate' from BMAZ, BESCOM for the requisition load of 16 MW is hereby issued for the proposed Residencial Apartments in favour of M/s. Purvankara Constructions, at Sy. No. 30, 31, 32, 34 & 161 Kadathanamale Village, Doddaballapura Road, Bangalore at C-7 Sub-Division, Addl. Central Division, subject to following conditions:-

1. M/s. Purvankara Constructions have to establish a new 66/11 KV consumer sub-station of 2x20 MVA capacity at the above premises by constructing 66 KV double circuit line with coyote ACSR on DC towers from 220/66 KV Doddaballapura Sub-station to the proposed consumer station for a distance of 8 Kms besides constructing additional 66 KV bay, duly providing 66 KV breakers, CT's Control Panel, Control Wiring, GOS etc under self execution.

- 2. Alternate power supply shall be arranged by the consumer by executing the following works under self execution:
  - a. Construction of LILO line from the existing 66 KV DG Plant-DB Pura-2 line to the proposed consumer sub-station using Coyote ACSR conductor on DC towers.
  - b. Replacement of existing copper conductor 1/0 of DC lines from DG plant to the proposed tapping point i.e. from LOC1 to LOC41 by coyote ACSR conductor.
  - c. The released copper conductor should be credited to the BESCOM stores.
- 3. All the above works shall be carried out through the Government Class-1 Electrical contractor under the guidance of the KPTCL.
- Execution of works mentioned above has to be executed from your end at your cost under self-execution on payment of 10% supervision charges on estimate cost.
- 5. Payment of augmentation charges for availing HT power supply on 11 KV and observance of other formalities mentioned in conditions of supply of Electricity of Distribution License.
- While applying for power supply to the said MS Building/various buildings
  at the above address, all rules as per KERC ES&D Code shall be observed.
- 7. Power supply will be arranged to the various buildings that may come up at the above address as per the provisions of regulations of BESCOM at that time.
- 8. This 'NOC' is issued only for the purpose of obtaining sanction for the MS Building plan from BDA/BMP/BMIC/Competent authorities and is not a commitment for power sanction from BESCOM. Power supply will be sanctioned when applied for, subject to feasibility at that time.
- 9. The approximate load requirement of the above MS Building is 16 MW.

10. The Validity of this NOC is for a period of Twelve Months only.
