

Request for Proposal (RFP) for Forensic Audit Services

We are pleased to invite reputable financial audit firms to submit a proposal to conduct a forensic audit of the accounts and records of Provident Welworth City, an apartment society located at Marasandra, Bangalore 561203. The purpose of this forensic audit is to trace a missing amount and identify any financial irregularities, mismanagement, or fraudulent activities during the specified period.

1. Background Information:

Provident Welworth City is a residential apartment society comprising 3360 units. The society operates under a registered association and manages various financial transactions, including maintenance charges, utilities, and other related expenses.
